RESOLVED THAT:

1. Pursuant to section 177 (1) of the Companies Act 2006 George Busfield has declared his interest in the Contract (as defined below) as set out in a letter from him dated August 2009;
2. 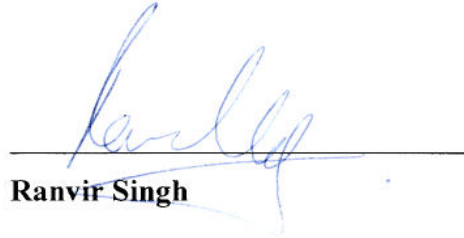

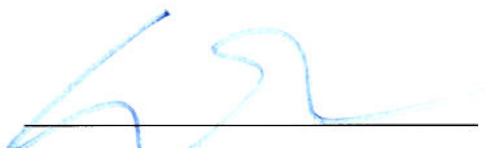
Written Resolutions of the Directors of the Company pursuant to Regulation 93 of the Companies (Table A to F) Regulations 1985 effective 2009

RESOLVED THAT:

1. Following the passing of the two special resolutions on August 2009 the Company purchases 25 ordinary shares of £1 each in the capital of the Company held by Cynthia Elizabeth Chenhalls Busfield for the sum of £33,420 out of distributable reserves of the Company;
2. The Company enters into a share purchase agreement with Cynthia Elizabeth Chenhalls Busfield for the purchase of the above said shares in the form approved by the eligible Members;
3. Following receipt of a signed stock transfer form, the transfer of 13 ordinary shares of £1 each in the capital of the Company held by Ranvir Singh to Cynthia Elizabeth Chenhalls Busfield for nil consideration be approved;
4. Following receipt of a signed stock transfer form, the transfer of 10 ordinary shares of £1 each in the capital of the Company held by Matthew Cheung to Cynthia Elizabeth Chenhalls Busfield for nil consideration be approved;

5. In consideration of the receipt of the sum of £33,420 from Anthony John North being in full payment of the outstanding loan to him in this amount, the Company agrees to terminate with immediate effect the loan agreement with him dated 9 September 2008; and
6. The company secretary be instructed to update the Register of Members and issue share certificates to Cynthia Elizabeth Chenhalls Busfield, Matthew Cheung and Ranvir Singh according to the number of shares held by them.

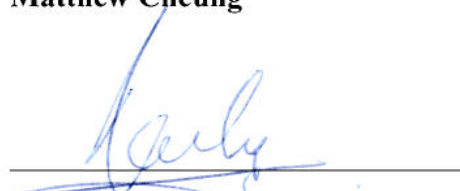
