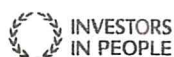

- The Outgoing Party agrees to indemnify the Incoming Party against any losses, damages or costs it suffers or incurs under or in connection with the Contract as a result of the Outgoing Party's failure to perform or satisfy its obligations under the Letter or under the Contract prior to the Effective Date.

The Contract will in all other respects continue on its existing terms.

From the Effective Date, NatWest Mentor Services will deal solely with The Jet Group Ltd in respect of the Contract; all invoices and correspondence relating to the Contract will be sent to The Jet Group Ltd at the address set out above, marked for the attention of Ms Anita Darbar.

If the Contract is governed by English Law, English Law applies to this Letter. If the Contract is governed by Scottish Law, Scottish Law applies to this Letter.
