Hi George and Adam

Please see attached claim for £11,000 plus costs from Singh for losses incurred under the injunctions.

There are two grounds:

1. Losses from the injunction of approx £8,500. They do not specify the grounds in which they claim the injunction was wrongly granted. Also given that we granted every request for release of funds this claim is totally without merit as Singh could have asked us to release funds for the tax to be paid. They also claim £6500 in costs.

2. The discharge of the injunction. I wrote to the banks advising them that the injunction was no longer of effect. This claim is just for the legal costs of £2500 in getting the banks to unfreeze the accounts after I had written to them.

You will see that the application must be made by 4pm Friday.
