You might be interested to know that GCV Ltd, the company that has siphoned more than £500,000 from The JET Group Services Ltd, Trade The News Ltd, and Real-time Analysis and News Ltd between 2017 and 2018 has filed accounts. I don't believe to be accurate, as the numbers do not money illicitly siphoned from these companies on the GCV accounts.

You were investigating this under CFSS-2424623 / ISBC/S0486/249741476/KDP - I was a director at the time money was siphoned from The JET Group Services and I believe Mr Hayward of will testify/witness that £331,000 was taken from Real-time Analysis and News Ltd in 2017.

You may wish to look at the letter you sent on the 29th Nov 2018 where you questioned Mr Busfield as the controlling mind in all of these companies. I replied to that confirming your deductions from that letter.
