Brief Outline Address of Mr Earl and Mr Patel and Mr Hayward, and other(s) Misconduct and Defamation(s) of late and historic:

No doubt you will have noticed the extensive and repeated emails and such correspondence by Mr Earl of late particularly, and previously of Mr Mehul and Chandrakant Patel, Mr Aubrey Hayward, and Mr Adam Linton historically, such as made numerous and extensive defamatory false and non factual, harmful allegations regarding payments as have been made to GCV historically and indeed recently.

Similarly you will all note that no response or replies have as yet been provided in earnest on these matters, as has been discussed and as agreed by the parties herein, simply because to do so will only likely, knowing Mr Earl, inflame the situation at harm to the companies' herein and thereto.

Nonetheless, our recent discussions I believe are to consolidate our thoughts in imminent forthcoming communications, in addition but in a similar vein to that provided below, across all parties hereto and to Mr Turner as the accountant and auditor of such companies' accordingly and such as the facts, realities and all absolute, comprehensive and definitive evidence is provided to Mr Turner and the Auditors accordingly and relevantly, such as to ensure categorically that the facts and authorisations, approvals, evidence and documentation such as underpins the true bona fide position(s) as are relevant hereto, and for audit and governance purposes are available, provided, documented and filed - such that appropriate due fiduciary and ethical and moral actions can now shortly be implemented to address the extensive misconducts by MR Earl and others as are clearly at hand and indeed were raised and discussed by myself, all parties hereto, Mr Turner, Mr Voce and Mr Bailey back in 2018 in regards to these matters and the believe of conspiracies to defraud and numerous other malfeasances such as I / we / parties hereto are to evidence further, as indicated, in due course shortly.

For transparency and avoidance of doubt, given my health and time available, I attempt to attach some of his related correspondence to this email for reference and try to summarise some of the key issues/matters and false defamations below - whereby MR Earl has alleged and I respond on behalf of all hereto:

- 1. Invoices and Payments to GCV have not been duly approved and/or are not due, and as Mr Earl specifically highlights payments of x1 for £6900 and a x1 for £8,598.79 that he threatened to go to the police and record as theft perhaps unbelievably to many.

  IN RESPONSE:
- \* You will note that the £6,900 was credited back to JET(S) in any event, albeit such was not required as per the attached and below forwarded audit evidence and contracts accordingly, and moreover as replicates the credit of a similar amount as has been advanced to JET(S) in previous months and as credited in the attached invoices also, perhaps i24.03 will provide the best / most quick summary illustration of such credits.
  - \* You will thus note all such payments are duly approved.
- \* You will further note that the payment of £8,598.79 is a direct payment to satisfy GCV invoice 'i25' which contains confidential information actually as is related to disbursements incurred by GCV on behalf of JET / JETS for security investigation and corporate forensic intelligence in light of Mr Earl and other's feared actions. Regardless, it is a due invoice, supported by disbursements invoices, and in any case approved by all appropriate parties as per the below and attached document. This invoice is included herein with all authorisations and approvals as required.
- \* You will also note from the attached and below correspondence that GCV has extensive outstanding debts and loans (despite HUGE voluntary credits it has offered) from JET(S) GCV has advanced loans such as are totalling circa £123,877 per GCV invoice i28, and all of which have been advanced to support "RANsquawk" and "Talking-Forex" trading businesses and the owing entities thereto as JET /JETS Limited.
- \* It is worth noting arguably at this point, that Mr Earl is NOT entitled to various correspondence, he is supposed to be head of IT for the companies' hereto and yet it seems he has not done any IT development but simply sought to try and position himself to attain a position of control such as he can unlawfully and extensively blackmail and try to leverage his position to seek financial reward and corporate control for himself which evidently he is obviously not entitled to. BUT more to follow on these matters imminently I believe.
- \* Moreover as a result of audit actions and other investigations, it is now / has now become seemingly very evident and overtly that Mr Earl has been consistently reaching his fiduciary duties, failed to complete governance actions as he is obliged, and duly and associatedly completed an array of unlawful actions and misconduct(s) again as will be addressed in detail in due course I believe asap.

GCV LTD / A Voce will attempt to issue this second payment defined in 2b above - prior to 9am - given it was due at the weekend, but only subject to and on condition of the following, as for which approval as necessary will now be immediately sought:

1. The relevant Disbursement invoice as attached as "i28.2" for the above two payments is hereby submitted and duly promptly authorised and approved asap - by return and in response to this and/or related emails as follow - and preferably due to the above prior to 8.45 am, and as is therein to be equivalent to the payment of the sum outstanding for both the above amounts in totality, and such as to be immediately to be paid to GCV by The Jet Group Services, and with any and all transfers as may be required between The Jet Group Services currency accounts to be also simultaneously duly authorised as may be required to enable such payment to GCV for the sum total of "i28.2" as stated which equals the sum of the payments GCV has / will be making direct to the HMRC on their behalf.

2. Under the circumstances GCV / A Voce will require payment in full for "i28.2" prior to making the 2nd payment hereto of £8,577.09. But warrants to do so immediately upon such settlement of "i28.2" accordingly.
