Dear Cindy/George/Adam,

I am just about catching up on all of this and thought i'd send an email to voice my concern over a lot of what has been discussed.

Dear Mr Busfield and Mr Voce

I write on behalf of myself and my wife, Mrs Sonia Singh, in reply to 2 emails we have received namely;

1. From email address <u>ransquawk@protonmail.com</u> on 07 July 2019 at 13:07 with subject "George Busfield" (various parties cc'd)

2. From email address <u>george@g-cv.com</u> on 08 July 2019 at 10:05 with subject "Mr & Mrs Singh - Request for Assistance with Audit & Compliance Investigations (IT / J Earl)" (various parties cc'd)

Both emails will referred to hereafter as "email 1", "email 2" or collectively "the emails".

I would like to state at the outset that both emails are highly inappropriate and inflammatory given the history between me/my wife and you/Mr Voce.

There is no foreseeable reason for you or Mr Voce to ever contact either of us. If there was some unforeseen set of events which meant either of you had to contact us, neither of us would be prepared to help you or Mr Voce under any circumstances.

I also note that neither email 1 or email 2 has been marked as 'Confidential' or 'Without Prejudice' and as such, you are more than happy for them to be shared publicly (which I will do so for our protection).

I further note that email 2 contains a number of spelling and/or grammatical errors.

YOUR EMAILS

I will now address the points raised - predominantly in email 2 - below;

1. You state that email 1 is a *"due reminder"* to contact me and my wife *"as part of the current Audit, Governace, Legal and Complaince processes underway at various companies and/or entities*

and/or trading businesses as are RANsquawk or associated/connected parties thereto..."

All of this is nonsensical for a number of reasons;

a. Reminders are not sent to recipients who are unaware they may be contacted by parties who they strongly wish not to be contacted by.

b. This particular 'reminder' is addressed to Ms Anne Conroy – HR Director at IBM London. IBM is not and has not ever been, associated with RANsquawk in any way.

c. Neither you nor Mr Voce are directors or employees of Real-Time Analysis & News Ltd (t/a RANsquawk) and are therefore highly unlikely to be carrying out any "Audit, Governance, Legal and Compliance processes underway" at the company or any related company.

d. The email address of the "reminder" is not a recognised RANsquawk email domain.

e. The email address for Anne Conroy (anne.conroy@uk.ibm.com) is also incorrect.

2. Furthermore, you put yourself out as writing "behalf of the Directors". Tellingly, you do not state which Directors you are writing on behalf of.

Given the reference to RANsquawk at the beginning of email 2 it can objectively be assumed that you are attempting to present yourself and Mr Voce out as writing on behalf of the Directors of this company.

However the email addresses you have used (<u>George@g-cv.com</u> and <u>Adam@g-cv.com</u>) are not RANsquawk email addresses. The URL <u>www.g-cv.com</u> is a holding page for "Ginkgo Capital Ventures" which gives no indication as to the legal entity behind the site.

Lastly, you have not cc'd any of the current Directors of RANsquawk.

All of these facts can objectively be described at best as suspicious and at worst, as potentially fraudulent.

It is for this reasons I have decided to cc in the recipients of the email contained in 1 above in this answer for transparency and to highlight what you are doing. Also, as the email address for Ms Anne Conroy is incorrect I have cc'd her PA, Ms Lesley Harvey.

3. On a substantive level I can confirm that my wife and I were subject to legal action on 2 occasions between 2016 and 2018 from Real-time Analysis & News Ltd. We did not raise "a legal claim" (as you state) as we were the defendants on both occasions.

You are very well aware of these facts as you were the signatory to much of the legal documentation issued by the company in both cases as you were a Director of the claimant at the time.

4. Any information from either case is confidential by way of a settlement agreement signed between myself, my wife and Real-time Analysis & News Ltd or by way of legal privilege, given the 2nd case was won by us by default judgement.

As such, neither myself, nor my wife are able to share any information with a third party unless this third party is an official body of HM Govt (eg - police, CPS, HMRC etc) and the

request is made in an official capacity.

If you believe you or Mr Voce are members of HM Govt I am happy to see supporting evidence of this.

If not, if you are still involved with RANsquawk you should have no problems accessing this documentation via the company's solicitor.

CONCLUDING STEPS

In conclusion, I believe your emails have been written to try and incite either me or my wife into committing actions that you will later use to commence further litigation against us and I feel nothing but utter contempt towards both you and Mr Voce for embarking on such a course of action.

I do not wish to hear from you again. If I, or my wife continues to receive emails from you or Mr Voce (in any capacity whatsoever) we will seek a restraining order against you both.

Given your history of being subject to such orders, I firmly believe we will be successful in another being granted in our favour.

Please delete our email addresses from any databases you may have.
