As you'll see from the attached document, I sent a letter to your VAT inquires department on the 20th Nov because I was unsure whom I need to direct it. Because it is a generic inquiries department they were unable to forward the letter to the correct department. See attached "HMRC reply" photo that I got back from them.

By sheer chance it appears you sent me a letter to my personal home address, so I now know where to direct my correspondence. It was addressed to the current director, Ivaylo Dimitrov, dated the 29th Nov. For your records, Mr Dimitrov resides at 40A Eaton House, Rodwell Road, London, SE22 9LF. In the meantime, I forwarded a copy to Mr Dimitrov yesterday.
