Dear Ms Pryse,

Further to the points you raise and my last two pieces of correspondence, I do not believe Mr Busfield is in any particular rush to file accounts for the company; albeit this may change in the coming week ahead as one of our merchant account providers (Worldpay) have threatened to stop releasing money collected after the 7th Jan 2019. It follows an annual review of our account with them that flagged that to the company had outstanding accounts due at Companies House.

Because JET Group and JET Group Services are linked, I have consulted a third party accountant to prepare statutory accounts for 2017 for The JET Group Limited, which I've included with this letter. If you have further questions, I'm happy also to provide CSV transaction records from the bank accounts to back these up. I believe from your letter dated 29th Nov 2018 under "submission of returns" that nothing should be filed until you are satisfied. They are provided for your benefit and to show my transparency, although you will have to wait for the actual formal accounts from by Mr Busfield and the firm's accountants. I also believe that if I were to file these,

it would jeopardise Mr Busfield filing accounts for JET Group Services. It will, however, enable

you to compare this set of accounts with the accounts Mr Busfield submits.

I also note last month that I received two letters sent to my home address, 33 Rothwell Road NE3

1TY previous month concerning VAT certificates (attached). I'm unsure of their significance, but I

believe Mr Busfield has ordered these. Are they being sent to my address because I requested

this in one of my letters, or because of an error? I would be keen for this to be clarified, just

because any post going to my home address should continue to also to go to the company's

registered address on Companies House as well myself.

Mr Busfield seemed very concerned that communication from HMRC had gone to me, as he

directs all correspondence to the companies accountants and uses their registered address. To

be very clear, I have not asked for changes in VAT / VAT dates / VAT payments and can only

assume that these requests have been undertaken by Mr Busfield to assist in his preparation of

the overdue accounts.

I would highlight and as previously stated Mr Busfield and Mr Voce control all of the entities and

that they are producing the accounts. While I am still a director at The Jet Group Limited, I will not

be signing any accounts created by Mr Busfield or the accountants as I have had no transparency

or input into their preparation. I have yet to see any accounts derived from PJ Marks, or Mr

Busfield, despite chasing the matter on several occasions. It is why I have sought an independent

accountant to provide the statutory accounts attached. Any documents received with my

signature should be questioned as such. My previous letter highlights Mr Busfield has made

changes at companies house unilaterally and without my signature.

As per my previous letter, I ask that the information I provide here be treated confidentially as Mr

Busfield is unaware of my dialogue with various authorities.
