I do not believe the development / IT work done for the company in the last couple of years would warrant any relief from R&D credits, and therefore any attempt to claim them would be fraudulent. I have concerns Mr Busfield might attempt to fraudulently do this in my name in the absence of my co-operation hence why I putting my position on record. I believe this could be an example of Mr Busfield trying to fraudulently claim tax credits as a means to reduce the overall tax liability due.

Other statements asserted by Mr Busfield regarding ill health and attempts to contact me are greatly exaggerated. At the point that email was sent, Mr Busfield made one attempt to call me in the last week. The fact he has blocked me on Whatsapp suggests quite the opposite in fact.

Your input is required so as to expediate matters and/or to provide support and/or detail to the current assumptions and/or possibilities and/or opportunities as are perceived to likely provide significant progress and value to the relevant entities via R&D Credits or otherwise.

Therefore please kindly call me on my mobile asap such that I can discuss accordingly and then duly pass on your views / commentary to Versa to input to the various Accounts as are effectively now completed pending such input from yourself as related to the matters indicated or as otherwise.

Your delay in responding is causing unnecessary difficulties and may result in significant financial harm to the related entities as are referred to herein.

Perhaps to assist and/or encourage a prompt response, noting the ethos of your prior email as I informed, I am currently working gratis for March, as I have similarly been for Jan and Feb 2019, due to the hindrance / restrictions as have been unfortunately imposed on me in such time (formal confirmation of such provided to relevant parties).

In any event, and disregarding any decline in our personal relationship, and/or in my health, I am still trying to assist the business and related entities as best I can, in the finalisation of accounts or otherwise. Therefore please kindly respond as requested asap.
