THIS Novation Agreement is made the 24 day of May 2017.

BETWEEN:

- (1) Interactive Data (Europe) Limited whose principal place of business is at Fitzroy House 13-17 Epworth Street London EC2A 4DL ("Vendor"); and
- (2) Ransquawk whose principal place of business is at 1006 - 1008 Moor Place, 1 Fore Street, London EC2Y 5EJ ("the Customer"); and
- (3) The Jet Group Ltd whose principal place of business is at 1006 - 1008 Moor Place, 1 Fore Street, London EC2Y 5EJ VAT Number (applicable only for EEA companies): ("New Customer"); **GB 249 7566 53**

WHEREAS:


- (A) Vendor and the Customer entered into a Service Subscription Agreement dated 29th June 2016 ("the Agreement").
- (B) In consideration of New Customer agreeing to assume all obligations and liabilities of the Customer to Vendor under the Agreement, the Customer and Vendor have agreed to release each other from all obligations and liabilities thereunder on the terms set out below.

NOW THEREFORE IT IS AGREED AS FOLLOWS:

1. New Customer undertakes with immediate effect to assume all rights, liabilities and obligations of the Customer set out in the Agreement and undertakes to observe and perform in favour of Vendor all obligations previously assumed by the Customer in favour of Vendor under the Agreement to the same extent as if New Customer had been a party to the Agreement.
2. Vendor undertakes with immediate effect to observe and perform in favour of New Customer all obligations previously assumed by Vendor in favour of the Customer under the Agreement to the same extent as if New Customer had been a party to the Agreement.
3. Without prejudice to any claims which may arise or have arisen in respect of any obligations or liabilities prior to the date hereof, the Customer and Vendor hereby release and discharge each other from all obligations and liabilities under the Agreement.
4. New Customer acknowledges that all payments made by the Customer and the performance of the Customer in connection with the Agreement prior to the date hereof shall be deemed to have been made with the authority and consent of New Customer.
