Dear Mrs Busfield,

I am seeking legal advice on this matter.

I find it highly suspect that a 3rd party is sending this letter on behalf of Mr Dimitrov. The writing style of Mr Dimitrov's letter is identical to the one emailed by yourself at 3am last week, 16th Aug and 3pm on 19th Aug.

In the meantime:

- I have not received a copy of this document in the post.
- If Mr Dimitrov believes he holds a document that I have signed, please provide the original letter featuring the wet signatures so I can verify it and the contents, along a copy for my own keeping as you have failed to attach a copy via email.
- I would be grateful if the witnesses (Mr N Ost & Mr E Janes) could attend with government prescribed identity documents.
- I would suggest we meet at the company offices to present this information
- I believe these measures are required due to suspicions of fraud and cybercrime.

Please provide me CCTV footage of the document signed in the presence of the purported witnesses by Tuesday at the latest. As you raised the matter of CCTV and offered this, I trust there will be no issue with this.

I note that the CCTV footage was not made with my prior consent. Now you have formally highlighted that archive CCTV footage exists and the fact it in this instance, it was not used for burglary prevention. I believe I am entitled to make a SAR (Subject Access Request ) in line with the DPA 1998 / GDPR 2018. Please provide me with **all** other CCTV footage held (by the company and Mr Busfield) of me between 2016 and 2018 inclusive by 1st Oct 2019.

Indeed, it is my understanding that you will hopefully, as proposed and discussed I believe, revert in the near future such as support such aspirations and endeavours so as to benefit all parties of relevance hereto.
