Mr Cole,

I am seeking advice on the matters you raised in your letter. However, with requests 1 - 3, it appears to me from your letter that you have been misinformed over the financial position of the company and its relation between the two companies, TJGL and TJGSL, and its trading history. Please clarify who provided you with these statements.

Regarding request 4, it should be noted that I have had virtually no involvement with company accounts. The accountants, Versa Accountants Ltd, who act on behalf of both companies have excluded me in the process. It can be illustrated from emails spanning an 18 months period where my requests over the accounts had been actively ignored. I filed accounts prepared by Versa some weeks back because the company was about to get struck off the register. I have raised my concerns over accounting matters with HMRC throughout the last year. My understanding is that the accounts prepared by Versa (PJ Marks at the time) for TJGSL did not get filed which I find concerning. In the absence of my involvement, I would like to know whom Versa was taking instruction from.

I resigned from TJGSL in Aug 2018 following the structural changes made to TJGSL in June 2018 that were not ratified by stakeholders. I believe the replacement directors are merely names used by the current shadow directors.

Unfortunately, I am no longer in a position handle TJGL matters as my powers as a director has ceased.

Also, as Mr Hayward noted, I would like to know under GDPR SAR who provided you with my personal email address? I did not consent to it being used as this is a business matter. Please ensure it is not used going forward.
