Jason,

I am sending this email just to confirm and keep a record for us both that I have tried to call you tonight (at 22.34 so my phone log tells me).

You did not answer, albeit you and I are aware we are both often similarly awake at this hour and given I asked my mother to forward you the same message (as I think you have 'blocked' me on whatsapp) I note you were and have been on Whatsapp since.

However, I am not sure any of the above is even materially relevant to the intent of my calling (and subsequent message), given both my call and message were very simply sent by myself, on behalf of myself only, with consideration that perhaps if you and I were able to speak directly (rather than via emails and/or heresay and/or 3rd parties etc), we together just might be able / have been able to help all parties including yourself and (as per my text) people I care about in expediting the address and resolution(s) to current matters at RANsquawk – simply by engaging in direct conversation.

As per my message, given the significant conflict(s) between yourself and either myself and/or my mother and/or other parties of relevance, it was not easy to call but as stated I wondered / hoped that it might actually have been able to help matters and individuals materially.

Anyway, you did not answer and so far as I am aware have not replied.

Hence, I can but only assume you will not - given I am aware you have read the message on Whatsapp from my mother already.

Thus I guess my effort was futile (perhaps inevitably in the circumstances) - but so it is, and I am satisfied that I can feel that I least I tried to approach you directly even under current circumstances etc.

So, to conclude, and as said in the respective message as I attach to this email, if you do reciprocate that to speak may be helpful then I have and hereby again convey that I am willing to try do so (at least in the very short term and prior to relevant circumstances evolving such as may realistically extinguish any such opportunity) and also to state / say / reiterate that this call and subsequent message as I have sent to you this evening, and asked my mother to also forward, and such as I attach to this email, were undertaken on a strictly personal basis only - by myself and on behalf of myself only - albeit I have shared my actions and text with my mother and other relevant parties for their information.

I provide this email to provide a record of these events; but save that you wish or choose to respectively and promptly reply or call me directly then it is to be assumed that this concludes this matter and activity
